Vide this office letter No. 4-02/2014–Restg Vol.V (Pt.) dated: 27.08.2020, instructions were issued for revision in consolidation of Business Areas, Category & Structure of BAs. Consequent to the orders, proposals for modifications in BA structure were received from 8 circles (GJ, OD, UTKD, PB, AS, BH, MP, UP(W) circles & FICO & ERP, cell Ghaziabad.
