**Subject: Wrongful addition of name of BSNLOA on 17.07.2020 in the eligible list of associations for 2<sup>nd</sup> Membership Verifications of Executives Associations after the earlier list published on stipulated date of 13.07.2020 - Gross violation of the poll process- Needs immediate removal of name-Reg.**

**Respected Sir,**

We lodge our strong protest on the illegitimate addition of name of one of the association namely, **Bharat Sanchar Nigam Limited Officers Association (BSNLOA)** after the expiry of the period in the list of eligible associations vide letter under reference #1. The valid list of eligible associations (total nine numbers) has already been published vide letter under reference #2.

The crucial dates in an electoral process are of vital importance and it can't be compromised. But here in this case the name of BSNLOA has been added lately on 17.07.2020 after publication of first list on 13.07.2020. As per the notification of the 2<sup>nd</sup> Membership Verification the following are the crucial dates:

<i>Release of list of eligible associations</i>	:	<b>13.07.2020 (Monday)</b>
<i>Last date of withdrawal of application</i>	:	<b>17.07.2020 (Friday)</b>
<i>Release of list of final eligible associations</i>	:	<b>24.07.2020 (Friday)</b>

**The addition of the name of BSNLOA on 17.07.2020 on the flimsy ground that it is left inadvertently and came to knowledge after four days of publication of the list of eligible associations is extremely doubtful and seems to be done purposely to either benefit some corners for some specific number in the ballot paper or derail the process. Whatever is the case, this is an illegitimate action and needs to be corrected immediately by dropping new addition of BSNLOA from the list of eligible associations and whole things should be enquired upon to unfurl the truth.**

Accordingly, we once again demand for removal of name of BSNLOA from the list of eligible associations as issued on 17.07.2020 to observe sanctity of the election and ensure free, fair and transparent election process of the 2<sup>nd</sup> Membership Verification of Executives Associations slated to be held on 18.08.2020.
