Subject: Inordinate delay in issuing the seniority list for Vacancy year 2007-08 onwards of SDE (T) Grade and finalization of provisional list-9 for VY 2006-07- Reg.

Respected Sir,

We would like to draw your kind attention towards the delay in finalizing the Seniority List-9 of SDE(T) grade for the vacancy year 2006-07 and publishing subsequent provisional lists for Vacancy Year 2007-08 & 2008-09.

Sir, after a long deliberation on seniority issue, BSNL management had taken a stand and provisional list-9 of SDE(T) cadre for vacancy year 2006-07 has been published on the basis of Quota mentioned in the SDE(T) Recruitment Rule. On 10th August 2020, the said provisional list has been published and called for any Error/Omission of individual candidates in the said published seniority list within 15 days timeline. The corrections and representations already reached to the office long way back and sufficient time has been elapsed since given time limit of 25th August 2020.

During deliberations in the formal agenda meeting on 15-09-2020, it was conveyed to us that List 10 for vacancy year 2007-08 has also been approved in file by competent authority and ready to be displayed and BSNL has taken a stand on seniority and will abide by the decision taken. It has come to our notice that some groups have again raised the same issue on which enough deliberations have already been taken place and due legal vetting has already been done by the Legal Section of BSNL CO. The list was issued after taking all the factors into consideration which were submitted earlier by various contending groups.

It is a must to bring in your kind notice that the list has been prepared by the management after discussion of 3 long years and sufficient time had been taken with each and every hierarchy of Management, then only decision was finalized by the competent authorities for publishing the list as per available rules and guidelines. At present no legal obstacle exists for finalizing the provisional list-9 and issuing List-10 for Vacancy year 2007-08 which has already approved.

Sir, in the light of above facts, we urge to your benign authority to direct the section for finalization of list-9 and issuing of the list-10 of SDE(T) cadre, as already approved by the competent authority. The continued neglect of genuine rights of competitive quota SDEs should not continue and it's high time that justice should be rendered to them by finalizing the said lists vacancy year wise.
