Sub: Provision of Security to Telecom personnel/offices in connection with the conduct of Membership Verification for election of Majority Representative Association of Executives' in BSNL slated for 18th August, 2020.

Sir/Madam,

Bharat Sanchar Nigam Limited (BSNL) was formed in the Year 2000. Since then, eight Membership Verification of non-executives employees and one Membership Verification of Executives' Employees through secret ballot have been conducted by us at various points of time. On all such occasions in the past, on our request, necessary police protection has been provided throughout the length and breadth of the country, on the date of polling and for counting of votes.

2. Needless to mention that such a gigantic task could be peacefully and successfully completed only with the whole-hearted help and support extended by the local law enforcing authorities. We are really thankful to you for the same.

3. Presently we are in the process of holding 2nd Membership Verification for election of Majority Recognised Association(s) of Executives in BSNL. The schedule for holding elections/counting of votes is follows:-

i)	Date of Polling	-	18.08.2020
ii)	Date of Counting of votes	-	20.08.2020
iii)	Declaration of result by CRO, BSNL CO	-	20.08.2020


4. Since BSNL is spread all over India, therefore, this election process involves BSNL offices situated in the entire country. For the purpose of elections approx. 300 polling booths have been set up. After the polling, the ballot boxes are required to be transported on the same day i.e. on 18.08.2020 itself to the Circles/SSA Headquarters of BSNL.

5. Though it is hoped that the elections will be held peacefully, possibility of disturbance of peace during the course of the elections cannot be entirely ruled out as the employees may get agitated in the heat of moment on account of varied interests of the participating Associations.

6. I would, therefore, request you to kindly issue suitable instructions to your subordinate units for providing necessary security to ensure peaceful conduct of polling on 18.08.2020, transportation of ballot boxes to District Headquarters on 18.08.2020 itself and during the counting of votes proposed to be conducted on 20.08.2020. The concerned Telecom officers in the field Units will approach the local police authorities in their respective Units separately to discuss the details of their requirements so that there is no disturbance of peace during the conduct of the elections.
