We are sure you are fully geared up to face the Membership verification to be held on 12th of this month and the BMS as a whole extends its best wishes to the AIGETOA for coming out with flying colours in the verification. It brings us great pleasure to extend our warmest regards to you and all the esteemed employees of BSNL.

We write to you today with a shared commitment and a common goal in mind – resolving the longstanding issues faced by the dedicated and hardworking BSNL employees. These issues have been a cause for concern for quite some time, and it is imperative that BMS as the umbrella organisation of AIGETOA and BTEU, must address them with highest priority. We comprehend the significance of these matters and the profound impact they have on the lives of numerous individuals and their families within the telecom sector. Therefore, we wish to assure you that BMS has been taking concrete actions to address the concerns which have been duly raised by AIGETOA and BTEU on our platform.

The issues of 3rd PRC, Standard Pay Scales of E2 for the entry level executives, Various Pay Loss issues, 30 percent SAB, extending one time option for pension under CCS rules to BSNL employees whose recruitment notification was issued during DoT period, problems faced by the PWD employees of BSNL and other issues as mentioned in your Memorandum have already been taken up with Hon'ble MoC by the General Secretary BMS and we firmly reassure that all these issues shall be advanced and raised at the appropriate level to ensure their resolution. We are aware that issue of implementation of 3rd PRC requires persuasion at the highest level in the Government to ensure the waiver of affordability clause and BMS remains committed to ensure the same in the best interest of the employees of BSNL.

This robust engagement with high-ranking officials underscores the momentum and support behind our mission to resolve the HR issues that have plagued BSNL executives for far too long. We are committed to building upon this foundation and elevating our collective voice to even greater heights. Together, we can make a substantial impact and secure the future we all envision. Following the upcoming G20 summit, we plan to pursue these issues with the Council of Ministers and the Honourable Minister of Communication. We are also pressing upon convening a tri party meeting involving AIGETOA/BTEU, DoT and BSNL for a formal discussion issue-

wise for a speedy resolution of the same. We believe that this is a pivotal opportunity to capture the attention and support of key stakeholders at the highest levels of government and hence we are keenly involved in ensuring that the issues mentioned in your memorandum sees the light of the day at the earliest.

Please do not hesitate to reach out to us with any suggestions, insights, or concerns regarding the problems or issues faced by BSNL employees. BMS will be happy to extend its support and cooperation for resolving the same.

Once again we extend our good wishes to all the BSNL employees in particular and to the BSNL in general for a bright future ahead.
