T codes for necessary data updation related to e-DPC/CPC/other guidelines have been communicated vide this office letter of even numbers dated 02.02.2021, 08.02.2021 & 03.03.2021.

Salient features of e-DPC/CPC (for time bound Upgradation as per EPP) are as follows

- 1. All CPCs for executives shall be conducted at circle level w.e.f 01.04.2021.
- 2. Any Time bound Upgradation under EPP due after 01.01.2021 and not conducted so far will be done in online mode w.e.f 01.04.2021.
- 3. No manual CPC shall be done w.e.f.01.04.2021.
- 4. VC status will be provided by concerned vigilance unit in online mode.
- 5. Vigilance head of circle office shall be authorized in SAP by the concerned CGM for processing online VCs for e-DPC/CPC.
- 6. AGM (HR) /DGM (HR) of circle office shall be authorized in SAP for conducting online CPCs. Necessary coordination in this regard may be done with ERP Cell.
- 7. Data related to the executives under consideration will be automatically fetched from ERP portal.
- 8. Scanned copy of Manual APAR shall be shown to the CPC members.
- 9. All online APARs shall be visible to CPC Members
- 10. Assessment sheet, Minutes of meeting/recommendation of CPC, Promotion order (Non-functional) shall be issued through SAP portal.
