Speaking Order

Subject: O.A. No: 3500/2016 filed by Rajeev Chauhan & 58 Others Vs BSNL in Hon'ble PB CAT New Delhi.

Reference is invited to Hon'ble PB CAT New Delhi order dated 18.01.2023 in O.A No: 3500/2016 filed by Rajeev Chauhan & 58 Others wherein Hon'ble PB CAT New Delhi gave direction as under:

"4. the representation dated 17.03.2015 shall dispose of by passing a reasoned and speaking order within a period of eight weeks' from the date of receipt of the copy of this order. The applicant similar situated persons already grant if the respondents consider the case of the applicant."

- 2. On examining of the documents attached with the said O.A.No: 3500/2016, it is found that representation dated 17.03.2015 is not available. However representation dated 17.03.2016 is available. It appears that it may be typographical error due to which representation dated 17.03.2016 is mentioned as dated 17.03.2015.
- 3. It is noticed that contents/issues raised in representation dated 17.03.2016 of Shri Krishan Kumar Khandelwal along with representations with different dates of other applicants which are part of annexure A-5 of the OA are similar in nature.
- 4. Accordingly, on consideration and examination of the representation dated 17.03.2016 along with 12 other representations of different OA applicants as enclosed in annexure A-5 of O.A all the representations by the Competent Authority following is hereby communicated:
 - i. In LDCE promotion order dated 26.05.2004, about 1509 JTOs were promoted as SDE against 25% DE quota on the basis of departmental exam held on 01.12.2002. Out of 1509, 124 executives appealed in CAT Bangalore for notional date of promotion. The CAT Bangalore Bench in original application No. 181 of 2009 decided on 26.04.2010 as "we direct the respondents to assign notional date of promotion as SDE to the applicant's w.e.f 23.01.2002, i.e, six months from 23.07.2001, the date on which the examination was announced to be held.........hence this decision cannot be applied as it ratio to finally decide this O.A. The applicant shall be granted consequential benefits................cost."

- In this context, it is informed that the issue regarding extending the benefit of notional date of promotion with all consequential benefits through promotion to SDE(T) grade under 33% LDCE quota has already been settled by Hon'ble Supreme Court in its judgment dated 12.08.2014 and subsequently in its order dated 02.04.2019 in Civil No.14967/2017 filed by Vinod Verma Vs BSNL.
- iii. It has been pronounced in the said judgment dated 12.08.2014 that "It is held that the view of the CAT Bangalore Bench in original application No. 181 of 2009 decided on 26.04.2010 and the decision of the Karnataka High Court dated 21.04.2011 affirming the decision of the Tribunal dated 26.04.2010 are not correct view and do not lay down the correct legal position. Since the special leave petition from the judgment was dismissed by this court on 25.08.2011 and a petition seeking review of that order has also been dismissed, the benefit of notional promotion given to 124 employees with effect from 23.01.2002 remains unaffected, but the benefit of the above decision cannot be given to the present respondents in view of the legal position explained above."
- The Division Bench of the Hon'ble Supreme Court, vide order dated 02.04.2019 in Civil Appeal No.14967 OF 2017 between Vinod Verma -Vs- UOI & Ors observed that the issue has been delved in the case of S.K.Dubey's (supra) and followed the ratio laid therein holding that:

"......In view of the facts as noticed above that the controversy raised in this appeal is covered by three-Judge Bench judgment dated 12.08.2014, we see no necessity to delve into various other arguments raise in this appeal. We are not persuaded to take any different view to one which has been taken by three-Judge Bench as noted above.

We, thus, hold that the present appeal deserves to be dismissed in view of the judgment of this Court dated 12.08.2014 Transferred Case (Civil) No..... of 2014(arising out of T.P.(C)No.184 of 2013)(Rajesh Banta & Ors. vs. Dewan Chand & Ors.) and judgment of the three-Judge Bench of this Court in BSNL & Ors. Vs. S.K. Dubey & Ors, decided on 12.08.2014. The appeal is, accordingly, dismissed."

Since the issue has been settled, the benefit granted to 124 officers cannot be extended to other similarly placed officers. Therefore request/representation of applicants for extending one increment under promotion to the grade of SDE (T) qualifying LDCE exam is not tenable and rejected.
