Respected/Sir,

This is in reference to our previous communication vide Letter No GS/AIGETOA/2022/112 dated 10.10.2022 we have highlighted that reimbursement policy should not be restricted to senior officers only but it needs to extend to all the executives upto JTO/JAO level.

In our last agenda meeting held with management on dated 8th February and 22nd February 2023 we again drew the attention of the management for early implementation as the same was the need of the hour. The same if implemented will not only boost the morale of the executives but also increase productivity. Finally in the meeting it was agreed that a policy in this regard shall be explored by management side for implementation initially at BSNL CO and the concerned field units shall replicate the same thereafter.

However, still after two months, the policy is yet to take shape. Hence, it is once again requested to direct the concerned section to finalize the laptop reimbursement policy for all the executives. We sincerely hope management will immediately issue orders to implement the same to all executives without any further delay. This will not only motivate the executives but also save the unnecessary expenditure incurred on procurement and maintenance of desktops, most of which have gone out of life.

We are hopeful that the above raised issue in right perspective and implemented in a time bound manner to enhance the motivation of the young officers in BSNL, which will ultimately benefit the organization only.
