Respected Sir

I am writing to bring to your attention a matter of utmost significance that directly impacts the livelihoods and future security of a dedicated group of BSNL employees. In the BSNL CO letter to the Department of Telecommunications (DoT) mentioned under reference 1, BSNL forwarded our letters, as cited under references 2 and 3, to the DoT.

However, we noticed that this communication erroneously addresses the issue only for those employees recruited by the DoT and sent for training before October 1, 2000, but who joined duty after the formation of BSNL.

At Sr. No. 3 of the AIGETOA NGC BA letter and Sr. No. 6 of the AIGETOA Chq letter mentioned in the BSNL forwarding letter cited in reference 1, we specifically requested the inclusion of TTAs who were recruited by the DoT notification and recruitment examination pertaining to the recruitment notifications by DoT for the CCS pension benefits.

We feel it is crucial to rectify this oversight as it completely disregards the genuine case of those who were recruited by the DoT before the formation of BSNL. If the DoT proceeds with the current letter for onward submission to the Department of Personnel and Training (DoPT), this important case will be entirely disregarded.

We believe it is imperative to rectify this discrepancy and ensure that TTAs who were recruited by the DoT notification before the formation of BSNL are rightfully included in the Old Pension benefits under CCS Pension Rules 1972, as per the provisions of the Government of India (DOP&PW) Office Memorandum dated 03.03.2023, which is cited under reference 5.

In light of the aforementioned circumstances, we kindly request your intervention to address this matter urgently. We trust in your leadership and commitment to the welfare of BSNL employees and are confident that you will take the necessary steps to rectify the oversight and ensure justice for this dedicated group of employees.

Thank you for your attention to this matter. We eagerly await a positive resolution that safeguards the interests of BSNL employees.
