**Sub: Disbursement of salary for May-2020 and clearance of Medical Bills pending since last one year.**

**Respected Sir,**

We would like to bring to your kind notice that once again the salary of May-2020 has not been paid in time to the employees. It's important to note that everyone is passing through a critical phase in his life due to the pandemic of COVID-19 and need sufficient fund for running expenditure and take care of any eventuality. In absence of any medical insurance and cashless facility by hospitals for treatment of BSNL employees, all are living in serious anxiety due to regular delay in salary payment and non-disbursement of medical bill since last one year.

We have been apprised that the collection has improved considerably in the month of May-2020 and upward trend is continuing. You will appreciate that the positive trend in revenue and collection is the result of serious efforts made by the management and all employees of BSNL. We are of the firm belief that under your esteemed leadership, we will turn around fortune of the company and it will be once again counted among profit making entity. But at the same time, motivation of employees especially the young, dynamic and professionally qualified executives are equally important and it should be nurtured, so that they should continue to work extra to fill the vacuum created by VRS in BSNL.

Accordingly, we appeal and demand for the followings:

- **The salary of May-2020 should be paid immediately and adherence of timely payment of salary form next month should be ensured.**
- **The payment of pending medical bills should be initiated. In case of fund issue the payment may be done in two parts. First arrange to clear outdoor medical bills and then indoor bills should be paid. But it's a high time to clear outstanding medical bills immediately.**
- **A suitable direction should be issued to Admin Section of CO Delhi and all Circles to liaison with hospitals to start cashless treatment to BSNL employees and if required part payment of their dues may be cleared. It should also be directed to start empanelment of remaining hospitals, who left over due to any issues. This will give urgent relief to the employees.**

Therefore, we once again request for immediate disbursement of salary and consideration of above request to instill confidence in the employees to work more aggressively towards BSNL.
