**Subject: Holding of free, fair, impartial and transparent 2<sup>nd</sup> Membership Verification-Reg.**

**Respected Sir,**


The notification for conduction of 2<sup>nd</sup> Membership Verification has been issued by above referred letter number dated 16.06.2020 along with the guidelines to be observed by the Circles during the period of membership verification. We have been apprised by our circle representatives that few circles are not observing the guidelines and insisting to act contrary to the guidelines issued by the Corporate Office, New Delhi. ***In this regard, we want to state that holding of free, fair and impartial membership verification process is the prime responsibility of the SR Cell, BSNL Corporate Office, New Delhi. So, we request your kind intervention for the followings:***

1. The office bearers of former majority and support association should not be given special facilities or previous immunities and office bearers of all associations should be treated at par after notification of 2<sup>nd</sup> membership verification on 16.06.2020. Since the extended privileges are already complete on 12-06-2020, all associations should be considered at par till 2<sup>nd</sup> MV is completed. So, any relieving of officers against already issued transfer orders should be executed in the defined window without any prejudiced.
2. As per guidelines letter issued on 16.06.2020 after notification of 2<sup>nd</sup> membership verification from BSNL Corporate Office, New Delhi, no fresh transfer order should be issued except
  - Transfer on Promotion
  - Tenure Transfer
  - Transfer on own cost/request
  - Transfer without change in the station of posting

But, it has been informed to us that UP(East) Circle is contemplating to issue the transfer of some executives after the notification of membership verification, which is a violation of model code of conduct. So, we request for you kind intervention in this regard to advise the circles to adhere the guidelines issued by BSNL Corporate Office, New Delhi as above.

**It is therefore requested to ensure strict adherence of the model code of conduct during entire period of membership verification process by all concerned. We hope that the SR Cell, BSNL CO, New Delhi will ensure completion of 2<sup>nd</sup> Membership Verification in a free, fair and transparent manner.**
