Subject: Incorporation of names of those executives in the SDE seniority list-9 for VY 2006-07, who were working as SDEs after promoted under Seniority Promotion Quota (DPC) but qualified in Competitive Quota i.e. LDCE held on 04.03.2012 and improved their VY position to 2006-07.

Respected Sir,

As per BSNL Corporate Office letter number 2-16/LDCE/2012-Pers-II dated 2nd July, 2013, the Promotion and posting of JTOs to SDE (Telecom) Grade issued in BSNL under Competitive Quota (33%) on the basis of Limited Departmental Competitive Examination (LDCE) held on 04.03.2012 by allotting the vacancy years 2006-07B, 2006-07, 2007-08 and 2008-09.

As per the para 10 of BSNL Corporate Office letter number 2-16/LDCE/2012-Pers-II dated 2nd July, 2013, the seniority revision/promotions of officers already working as SDEs (T) under 67% promotion Quota are being decided and their promotions will be issued separately provided their seniority gets improved under Competitive Quota on the basis of the results declared vide letter no 5-4.2013-DE dated 28.06.2013. The same was again clarified vide BSNL CO letter No 2-16/LDCE/2012-Pers.II dated 24th July 2013.

Subsequently BSNLCO issued letter for furnishing vigilance clearance vide referred letter number 2-16/LDCE/2012-Pers-II dated 6th Feb, 2017 and its remainder dated 17th Sep, 2018 (copy attached), wherein, list of 170 numbers of SDE(T)s were circulated, who got improved their seniority under Competitive Quota against vacancy year 2006-07, 07-08 and 2008-09. **But despite of improvement of the Vacancy Year to 2006-07 through Competitive Quota LDCE held on 04.03.2012, their names were not included in the published provisional seniority List-9 of SDE for VY 2006-07.** The publication of final seniority list-9 for the VY 2006-07 without inclusion of above SDEs may invite legal complications.

It is therefore requested your good self to look into the matter and issue suitable instruction to the concern authority for inclusion of the names of such SDEs in the published seniority list-9 for VY 2006-07, who were already promoted in 67% Seniority Quota on 30.03.2011 and improved their seniority by qualifying and got promoted in 33% Compleitive Quota for VY 2006-07 through LDCE held on 04.03.2012.
