**Subject:** Humble request to consider some genuine submission in view of LDCE for SDE (T) to be held on 15/02/2015

**Reference:** BSNL LDCE for JTO to SDE (T) (Notification vide Letter No 24-1/2014-Rectt, dated 13-11-2014).

**Respected Sir,**

This association humbly request to your kind for considering following genuine submission in view of LDCE for SDE (T) notified vide reference notification cited above.

- 1. Extending eligibility to the candidates recruited in same batch:** it is understood that some of the DR JTOs recruited through All India examination held on 21/06/2009 against the recruitment year 2008 had been called to join training in different batches due to constraints of training centre and other constraints in different circles. Training was called purely on random basis irrespective of their All India rank hence some of them even having lower rank joined their training prior to 1<sup>st</sup> July-2010 but some of them could join on or after 1<sup>st</sup> July-2014 despite have higher rank. Those who have joined prior to 1<sup>st</sup> July-2010 have completed three years hence eligible against the vacancy year 2013-14 but those who were called to joint training on or after 1<sup>st</sup> July 2010 did not completed three years. As all these candidates have been recruited vide same examination and declared successful vide same result but called training randomly cannot be discriminated in eligibility for LDCE for SDE (T). Government of India also protect the seniority of the candidates recruited in same batch even if he joined later up to six months for future promotion. ***It is also worth to mention that all DR JTO recruited against the recruitment year 2005 have been extended pay revision fitment benefit on same ground irrespective of their joining of training before or after 1<sup>st</sup> Jan-2007.*** As some of the 2008 batch DR JTOs have completed 3

years against the SDE (T) vacancy year 2013-14 hence eligible to appear in LDCE, hence you are kindly requested to consider the eligibility of all DR JTOs of 2008 batch irrespective of their joining date.

2. **Reducing the minimum passing marks to 45% instead of 50% as recommended by the committee:** at the time of last LDCE for SDE (T) notified in year 2010 and examination held on 4<sup>th</sup> March-2012 this association had represented with all justification to remove the negative marking or reduce the minimum passing marks. On the said representation one committee was formed and recommended for reducing the minimum passing marks to 45% and same was approved by Director (HR) from next LDCE. It is evident from the current notification of LDCE for SDE (T) that minimum passing marks are still mentioned 50%. You are kindly requested to consider the minimum passing marks to 45% in the said LDCE for SDE (T) as approved and issue necessary corrigendum.
3. **Issuing detail syllabus and distribution of marks for each topic:** kindly refer to previous notification of LDCE for SDE (T) where detail syllabus and topic wise marks are given which helps the candidates to decide the depth of study but syllabus in this notification is very brief and no marks division is given for each topic. It is needless to mention that there is no specific study material prescribed by BSNL and every field in telecom has no limit for study. Hence, you are kindly requested to consider our this request and issue syllabus in detail and distribution of marks for each topic.
